The principles of the present Convention shall be:

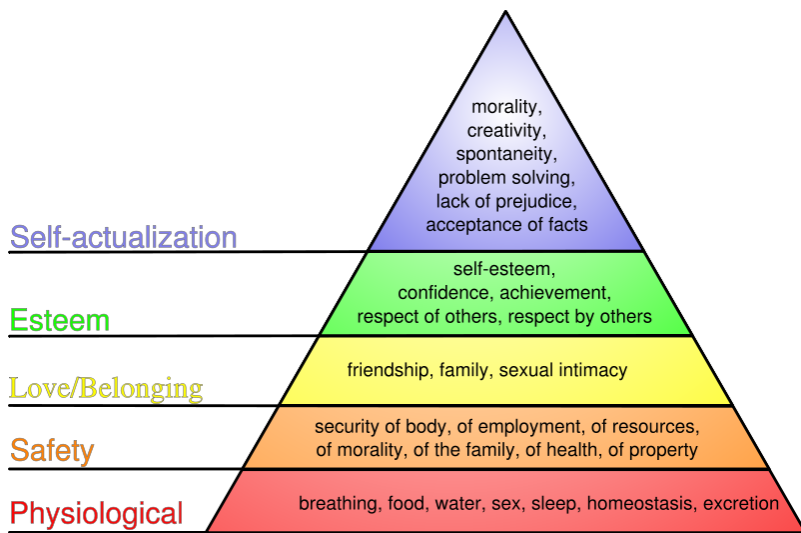
- a. Respect for inherent dignity, individual autonomy including the freedom to make one's own choices, and independence of persons;

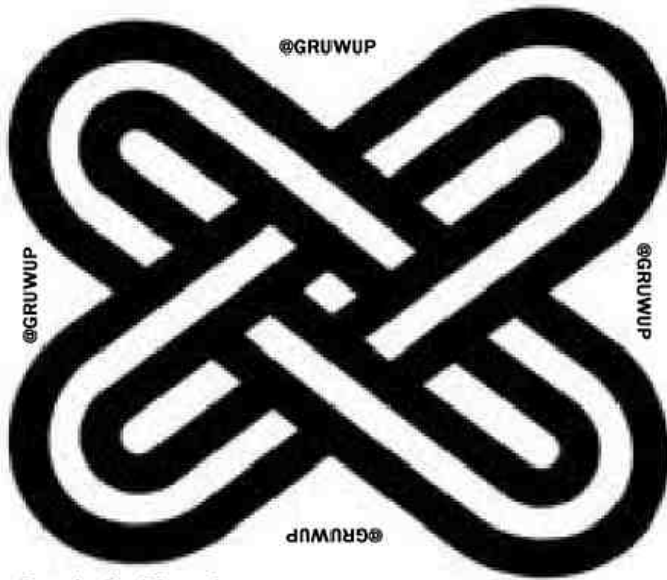
